The school undertakes to abide by the provisions contained in the Affiliation & Examination bye-laws, directions issued from time to time and the law of the land.
- 8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
